30% non-refundable deposit to secure your registration. 60% due on or before July 1, 2019. Remainder of payment due on or before September 15<sup>th</sup>. If you are choosing single supplement, the single supplement portion must be paid in full in addition to 60% of the remainder cruise cost on or before July 1<sup>st</sup>, 2019.

If registering after July 1, 60% is due upon registration including 100% of the single supplement if applicable. 30% is non-refundable. The final payment is due on or before September 15<sup>th</sup>.

NOTE: We will not be holding cabins after July 4th. If you wish to register it must be before July 4th.

2. I understand I am agreeing to attending the Joy of Living Cruise, October 6-11, 2019 aboard the Norweigan Joy Cruise Liner. I understand I must be onboard the vessel no later than 6pm on October 6, 2019
3. As part of the agreement, I am receiving 5 nights accommodation in a Balcony Room onboard the ship. I am responsible for all other charges including tips, airport transfer, airfare, shore excursions, and anything that requires an extra charge onboard or off the vessel.
4. I understand every possible attempt will be made to fulfill my requests as stated on the application form, but are not guaranteed.
5. This contract becomes binding with a 30% non-refundable deposit. If deposit is not received, then this contract is not binding and I understand my seat is not secured until payment is made.
6. I have reviewed the Cancellation Policy in the Application Form. I understand it is as follows: If I cancel on or prior to July 1<sup>st</sup>, 2019 my 30% deposit is non-refundable. Any additional monies that I have paid over and above deposit will be refunded. If I cancel between July 1-Sept 15, 2019 I agree to pay for 60% of total cost. If I cancel on or after September 15, 2019 I agree to pay for 100% of the total retreat cost. No refunds will be issued.
7. I understand 60% of the total owed is due on or before July 1, 2019 otherwise the facilitators will be forced to give up my cabin.
8. I understand I am responsible for my travel to and from the cruise ship, all incidentals, room service fees, individual spa treatments, alcoholic beverages, soda, and anything else not outlined in the cruise event literature.
